1. Fees are due in full 2 weeks before the start of the course.
2. Places on the course are given on a first-come-first-served basis and bookings will only be confirmed upon receipt of fees.
3. No attendance is allowed without receipt of completed booking form and full payment.
4. Parents/Guardians are not permitted to stay during Rhythm Circle sessions unless by special arrangement.
5. All personal property are the responsibility of the owner. Rhythm Circle cannot be held responsible for any losses or damage that may occur to personal property. Please do not bring valuable items to any classes or wrap-around sessions.
6. If your child is to be collected by someone other than the person dropping them off, you will need to advise Rhythm Circle and Wrap-around Care staff.
